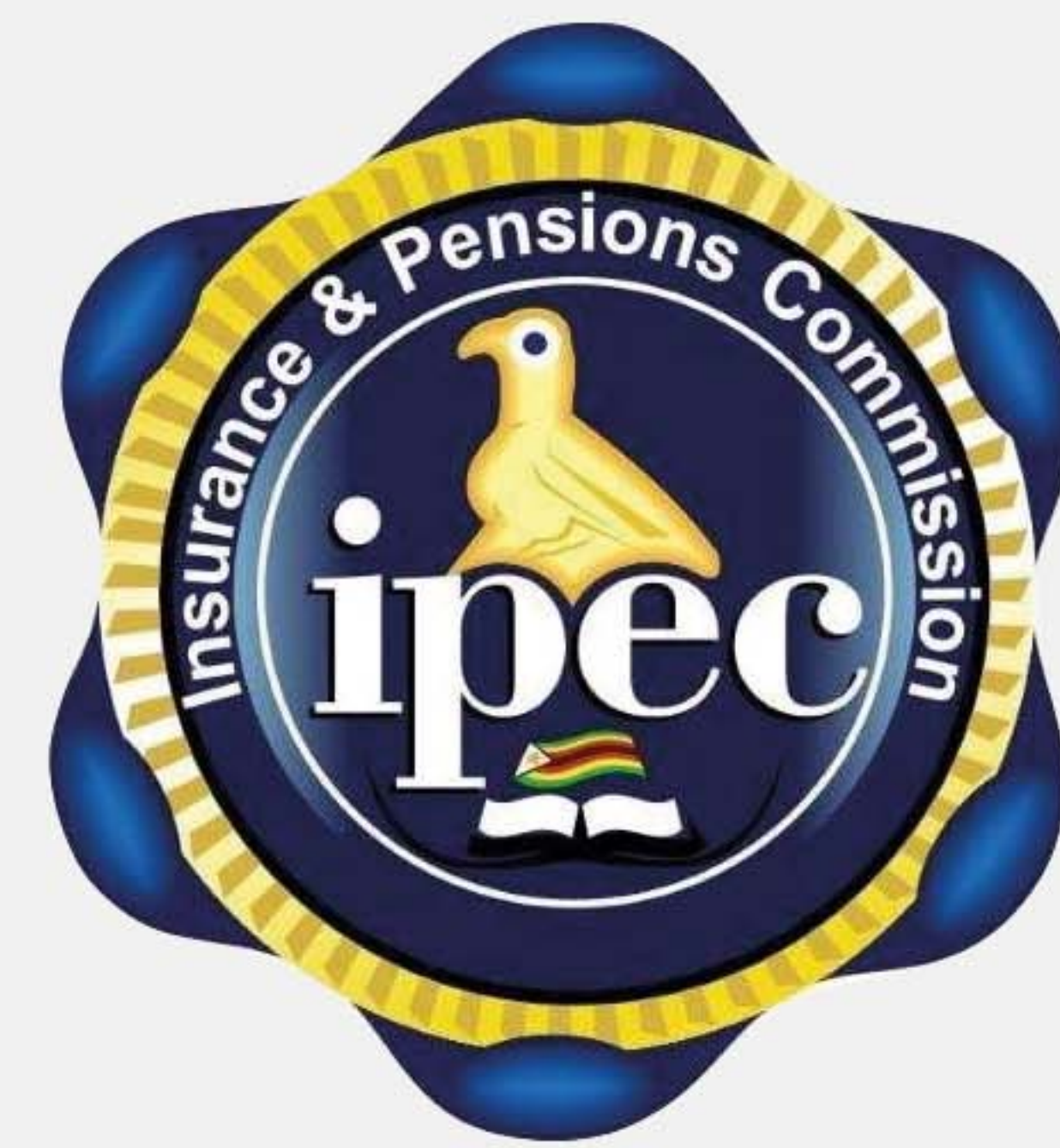

In the wake of AfCFTA, Africa's GWP potential is estimated to grow at the rate of 7% from about \$ 115 billion to about \$ 3.405 trillion in a span of 50 years. 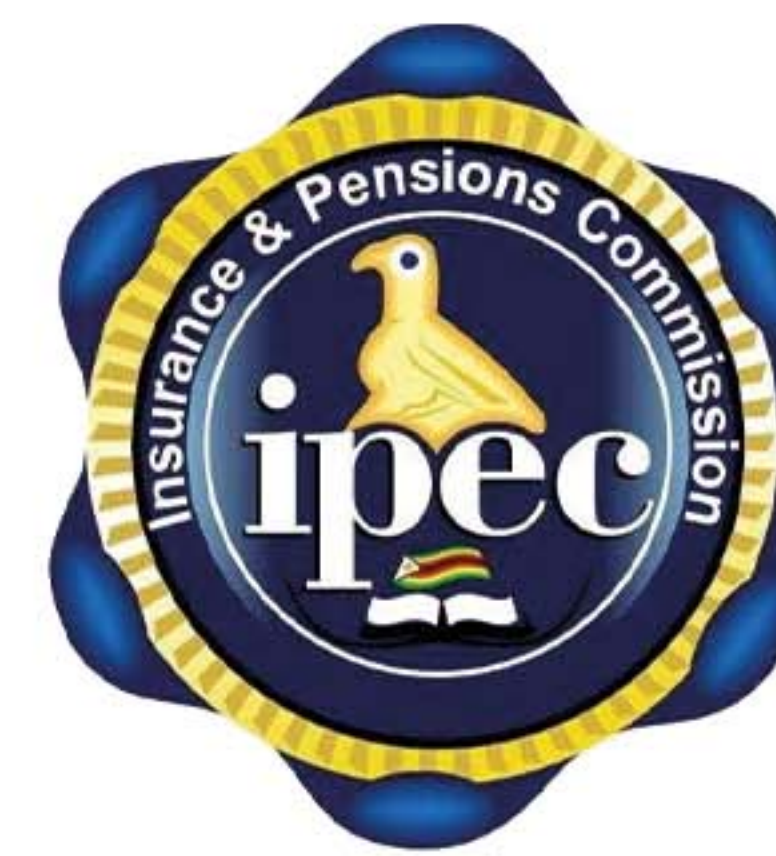

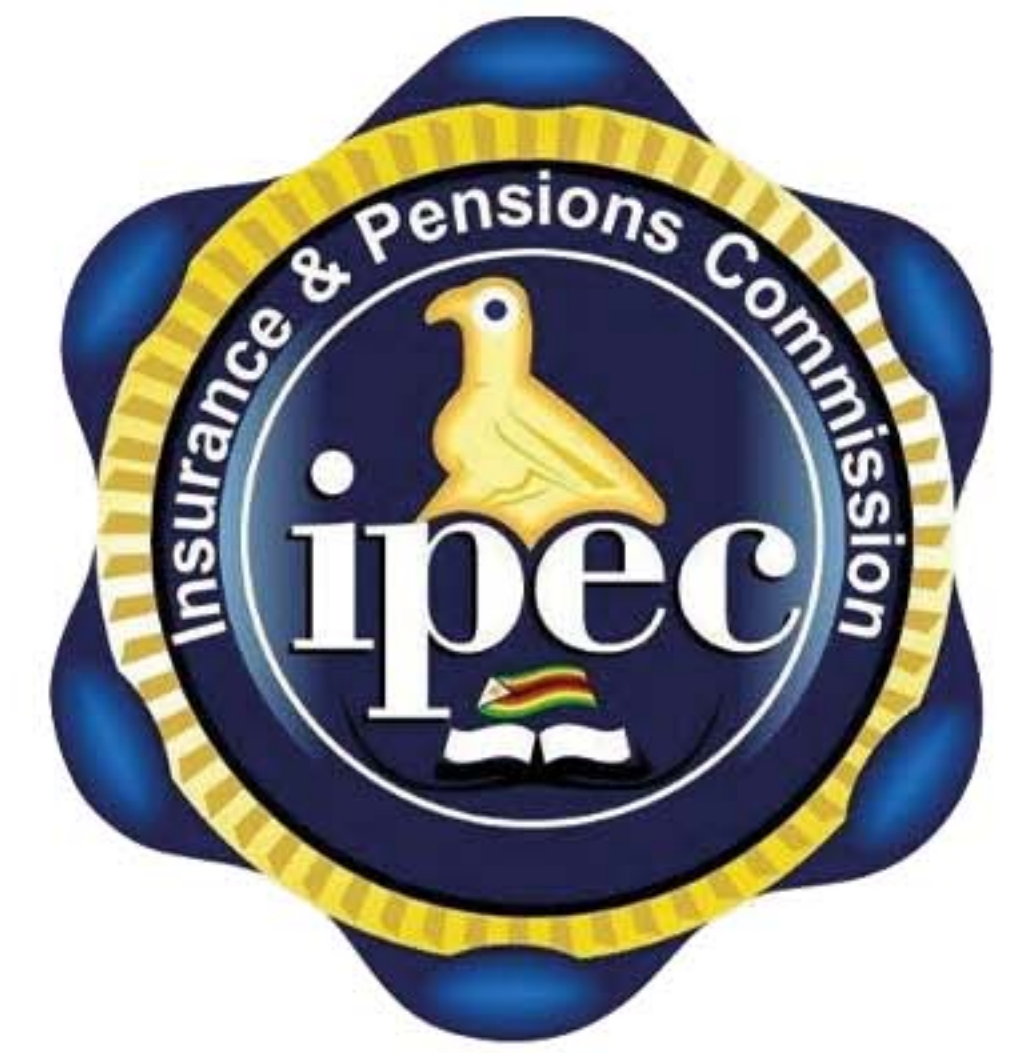
